Overview of Steps:

1. *Register for an NCID**
 2. *Request access/subscribe on site using NCID**
 3. *Wait for DPI approval**
 4. *Once approved log on to site!*
 5. *Complete the required fields*
 6. *Submit final by 15 July 2016 – for LEAs and existing charters. NEW charters – 15 October 2016*

Steps # 1 – 3: New Users ONLY!

Step 4: Log on to site

- Access 2010 – 2013 AND 2013 – 2016 tabs!
 - Review previous self assessment ratings
 - Download copy of either plan (word or PDF files available)
 - Review Interim Report data
 - View all attachments in Appendix
- Under 2016-2019 Tab – Enter new data here

Step 5: Complete the required fields

- Overall plan:
 - Vision & Mission
 - Funding sources
 - LEA general info
- Each standard:
 - Overall assessment
 - Ideas to strengthen the standard
 - Possible sources of evidence
- Each practice:
 - Overall assessment
 - LEA Response
- **Compose, save, print as you need**



Step 6: Submit your local plan

- Due to DPI --- Friday, 15 July 2016
 - NEW Charter Schools – October 15th
- Must have local board of education approval date to submit

Step 1: Obtain an NCID

- **For new users**
 - Work with district to obtain the NCID
 - See prepared handout for step by step instructions (allow several days)
- **For existing users:**
 - NCID does not change
 - If password has expired, go through recovery process on NCID site



Step 2 & 3: Request access/subscribe on site then wait for approval!

- First time users, go to site

- Complete and submit the form
 - DPI will approve the form – using the names submitted on google form
 - Once you receive the approval email – you are all set!
- Returning users may go directly to the site!
